## Third International Conference on Arbitration in Libya

“New mechanisms to support investment in Libya”

The Libyan Center for International Commercial Arbitration (LCICA) will hold its third arbitration conference in Libya, entitled “New mechanisms to support investment in Libya”, in cooperation with the Milan Chamber of Arbitration, on November 19, 2019, in Milan, Italy.

This conference is the third in a series of conferences of LCICA, which is concerned with spreading the culture of arbitration in Libya and the Arab and African world, and the development of cooperation between African arbitration centers, and support scientific research in the field of alternative means of dispute resolution.

### First and Second International Arbitration Conference:

Following the launch of the International Arbitration Conference in Libya and the success of the first International Arbitration Conference in Libya on 1 and 2 November 2017, entitled "Arbitration in Libya in the Light of Comparative Experiences and International Organizations", at the headquarters of the Organization of Education, Science and Culture "ALECSO" in Tunis In the presence of a significant number of lecturers and participants, and jointly organized by LCICA and the International Chamber of Commerce in Paris (ICC), following the Center's authorization from the Libyan House of Representatives and a license from the

Government of Concord, and after responding to the call of the United Nations to urgency and the development of an arbitration law. It focused on the task of drafting the law, after studying the experiences of countries that drafted laws in arbitration, which revised laws such as Tunisia, Egypt, Bahrain and others, in addition to international laws such as the law "UNICTRAL", in order to support and disseminate the culture of arbitration in Libya.

In the same context, LCICA held all the preparations and equipment of the Second International Conference on Arbitration in Libya under the title: "The Role of Arbitration and Mediation in Supporting Investments", in cooperation with the Cairo Regional Center for International Commercial Arbitration (CRCICA). The conference focused on the system of arbitration and mediation within arbitral institutions, in private disputes, in international investment disputes - and to what extent the judiciary intervened in arbitration and mediation. The conference concluded with a presentation of some practical issues in the field of arbitration and mediation and their impact on the resolution of investment disputes.

### Third International Conference on Arbitration in Libya:

LCICA, in cooperation with the Arbitration Chamber in Milan, is preparing to hold its third conference on arbitration and mediation, with the aim of introducing the center and the procedures in accordance with its rules, and to provide the latest developments in the field of arbitration and mediation internationally, and the extent of compatibility and compatibility with Libya, LCICA also aims to encourage investment in Libya, By introducing the new developments in the investment law and presenting the draft arbitration law in Libya.
